Course at Jalangi B.Ed. College, Narasinghapur, Sagarpara, Murshidabad, from the academic session 2007-2008 under the affiliation of University of Kalyani. I am to inform that on the basis of inspection caused by the university by a duly constituted inspection team, The Vice-Chancellor, University of Kalyani is pleased to extend provisional affiliation to your college for the academic session 2007-2008 for introduction of B.Ed. Course at Jalangi B.Ed. College, Narasinghapur, Sagarpara, Murshidabad subject to fulfillment of the conditions laid down in the inspection report.

I am further directed to inform you that-

- (a) Intake capacity of the College should be restricted to 100 (one hundred).
- (b) Recommended Fee structure be accepted.
- (c) Fee structure is inclusive of all charges including Registration Fee. No Extra Registration Fee be charged from any candidate separately. 10% of Course Fee deposited to the University as Registration Fees.
- (d) 10% of the total seats be kept reserved for poor and deserving candidates and in their cases charge should not exceed the limit of 25% of the total charges as recommended by the Committee.
- (e) Hostel Accommodation is not mandatory. Days Scholars should also be allowed for admission.
- (f) Selection procedure must come under the purview of common Entrance procedure conducted by the University of Kalyani.

- (g) Fresh advertisement inviting applications for admission to the Course be published in the leading Daily and the candidates who have already applied need not to apply again, but they may considered if not admitted already exercise their option.
- (h) Classes for the session 2007-2008 be commenced on 2nd July 2007.
- (i) You will have to deposit Rs.1, 00,000/- (Rupees One Lakh) immediately as one time affiliation fee to the University through Bank Draft on any Nationalized Bank payable at Kalyani.
